This Assembly notes:

- 1. The ongoing conflict in Israel-Palestine is having a severe impact on the wellbeing of different communities here in Lancaster.
- 2. There is an increased risk of hate crimes and violence, particularly towards our Muslim and Jewish students due to the ongoing conflict.
- 3. The National Union of Students' Guidance, made in consultation with impacted communities and Israel-Palestine: Avoiding Antisemitic and Islamophobic Hate Speech | SNS (solutionsnotsides.co.uk) guidance on how to discuss this matter appropriately and sensitively.
- 4. Many students have organised to publicly campaign for the Students' Union to publicly acknowledge the ongoing conflict.
- 5. A lack of a public recognition by the Students' Union has disillusioned some impacted Students from seeking support.
- 6. The Safe Space Policy and the need for the Students' Union to be proactive in its efforts to uphold this policy.

This Assembly believes:

1. Israeli and Palestinian people have the right to live in peace and prosperity; free from violence, free from fear.

- 2. This is a moment to support students, stand firm in tackling hate-speech and abuse, and de-escalate fear and tension on campus.
- 3. All parts of our Students' Union should be a welcoming and comfortable space for all students to seek support and community.
- 4. The freedom of speech of our organising students should continue to be respected in line with existing laws and policies.
- 5. All students should be acting with compassion and sensitivity for fellow students no matter their identity or their politics

This Assembly resolves:

- 1. To recognise:
 - a. The impact of the ongoing conflict on students in Lancaster.
 - b. The need to empower students engaged in debates and discussions with resources on how to discuss this topic sensitively and appropriately.
- 2. To firmly stand against islamophobia, antisemitism, and discrimination in all its forms
- 3. Release a public statement acknowledging the notes, beliefs, and implementing the resolutions of this paper.
