International Students' Forum Terms of Reference

1. **GENERAL**

- 1.1. These terms of reference are with regards to Lancaster University Students' Union (LUSU) International Students' Forum, a subcommittee of the Union Assembly as defined in the Union Assembly Bye Laws.
- 1.2. Amendments to this Terms of Reference shall be ratified by the International Students' Forum.
- 1.3. Significant amendments to the terms of reference that alter the fundamental purpose or powers of International Students' Forum will also be ratified by the Union Assembly.

2. PURPOSE

- 2.1. The International Students' Forum shall:
 - 2.1.1. Act as the collective representative body for international students.
 - 2.1.2. Elect the LUSU International Students' Officer and hold them to account.

3. MEMBERSHIP

- 3.1. Membership of the International Students' Forum shall be:
 - 3.1.1. LUSU International Students' Officer, who shall act as Chair.
 - 3.1.2. Members of societies executive committees, JCRs, and any other student leaders with a specific remit encompassing the experience of international students.
 - 3.1.3. All international members of the Students' Union.

4. POWERS OF THE FORUM

- 4.1. Direct the work of the International Students' Officer and hold them to account.
- 4.2. Collaboratively plan and deliver events, activities, and campaigns for international students and their interests.

5. **MEETINGS**

5.1. The International Students' Forum shall meet at least 3 times per year on-campus.

6. ELECTION OF INTERNATIONAL STUDENTS' OFFICER

- 6.1. The LUSU International Students' Officer shall be elected in the annual International Students' Forum Annual Meeting in accordance with the Democracy & Elections Byelaw.
 - 6.1.1.Only members of the Forum may vote for the LUSU International Students' Officer, in accordance with 3. *Membership*.
 - 6.1.2. Nominations must be submitted in-advance of the meeting, in a format and before a deadline set the Students' Union.
 - 6.1.3. Voting will take place via a secret ballot at the Annual Meeting.

7. ANNUAL MEETING

- 7.1. The LUSU International Students' Forum shall hold an Annual Meeting each academic year for the purposes of electing the LUSU International Students' Officer.
- 7.2. Only members of the Forum may attend and vote at the meeting, in accordance with 3. *Membership*.
 - 7.2.1.If it seems it necessary, the Students' Union may enforce measures to verify the eligibility of those in attendance.
 - 7.2.2. Space at the Annual Meeting may be reserved for members of societies executive committees, JCRs, and any other student leaders with a specific remit encompassing the experience of international students.
